- The Bid Submission Method is: **Physical Submission, Two envelope Submission Method** in which sealed original and all the sealed copies of the technical offer are placed in one separate sealed envelope whilst the sealed original and all the copies of the **financial offer** are enclosed in another separated sealed envelope. The two sealed envelopes are then placed in one outer securely sealed envelope.
- The financial bid should be separated from the technical bid. *Failure to do so will lead to disqualification.*

- One (1) original tender document marked **ORIGINAL** for both technical offer and financial offers and 4 duplicate copies of the original Documents marked **copy** in one sealed envelope clearly marked


