- The Procuring Entity is **Botswana Vaccine Institute Limited**
- Procurement Method is: **Open Domestic Bidding**
- Tenderers who are domiciled in Botswana must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority in the following categories: **PPRA Code: 315 – Human Resource Services**
Sub code: 01 - Organization Design and Change Management and
02 – Job Evaluation, Compensation and Reward Management
- The tender is reserved for 100% citizens or citizen contractors as stated under Section 76 (2) of the Public Procurement Act.

Preference margins will be applied to qualifying bidders in line with the prescribed Preference Scheme

Economic Diversification Drive (EDD) or

Local Procurement Scheme (LPS)

(Only one will apply which benefits the Citizen more).

- Documents will be emailed to bidders during working hours between 0730hrs and 1600hrs
- A non-refundable deposit of P250.00 amount payable by EFT or Bank Deposit is required before the tender documents are emailed to the bidders. Youth owned companies shall pay half of the tender price, proof required for verification.

- Late tender offers will **NOT** be accepted.
- The Bid Submission Method is: **Physical Submission, Two envelope Submission Method** in which sealed original and all the sealed copies of the **technical offer** are placed in one separate sealed envelope whilst the sealed original and all the copies of the **financial offer** are enclosed in another separated sealed envelope. The two sealed envelopes are then placed in one outer securely sealed envelope.

The financial bid should be separated from the technical bid. *Failure to do so will lead to disqualification.*

- One (1) original tender document marked **ORIGINAL** for both technical offer and financial offers and 3 duplicate copies of the original Documents marked **copy** in one sealed envelope clearly marked
